

**“XTRA PLAY XTRA WIN”  
FULL TERMS AND CONDITIONS**

Brembo S.p.A. (hereinafter the Promoter) with headquarters in Via Brembo, 25, Curno (BG), Italy, is organizing this Promotion, called “XTRA PLAY XTRA WIN”.

This Promotion is open to people residing in the United Kingdom, France, Germany and in the Netherlands, aged 18 years old or over.

Employees of the Promoter, and their immediate families, their agents or anyone professionally connected to this Promotion shall not be entitled to enter.

**Participation in this Promotion is free of charge and no purchase is necessary.**

The Promotion will be communicated to the participants on the Promoter’s websites, exhibitions, through newsletter, social network and other digital channels.

**1. Promotional period**

The Promotion will be communicated starting from 1<sup>st</sup> September 2019.

Participation to the Promotion is open from 15<sup>th</sup> October 2019 and closes on 14<sup>th</sup> November 2019.

Winner’s selection and possible recovery draw by 14<sup>th</sup> December 2019.

**2. Entry and participation**

During the Promotional Period, in order to register and enter the prize draw, participants must visit the website [www.bremboxtracontest.com](http://www.bremboxtracontest.com), fill in the form with all the personal data required (name, surname, and e-mail address) and select their country from the pull-down menu. The participant must read and accept these Terms and Conditions and the privacy notice. Optionally, the participant can give consent to receive newsletters and other promotional communications about Brembo products.

**INSTANT WIN**

After the registration, the participant can enter the Instant Win period, as follows:

- 1- The participant will have to select one product among the three Brembo Brake Discs proposed;

## 5. WINNERS' NOTIFICATION

### INSTANT WIN
